Information We Collect

Personal Information:

Usage Data:

Device Information:

We may collect information such as device type, operating system, and app version to improve performance and user experience.

How We Use Your Information

We use your information to:

- Communicate with you if you choose to share contact details
- Create and manage your playlists, subscriptions, and preferences
- Analyze usage and performance to enhance the app
- Comply with legal obligations

Legal Basis for Processing (GDPR):

We process your information only when we have a legal basis, such as:

- Your consent
 - To fulfill a contract (e.g., providing app services)
 - Our legitimate business interests in improving the user experience

Sharing Your Information

We do **not sell or rent** your personal information.

We may share limited data with:

- Service providers who help operate the app (e.g., analytics, hosting, payment processors)
- Legal authorities, if required by law

All third parties are required to protect your data and use it only as instructed.

Your Rights

Depending on your location, you may have the following rights:

- Access to the personal data we hold about you
- Request correction or deletion of your data

- Request restriction or objection to processing
- Request data portability
- Withdraw consent at any time (without affecting prior lawful use)

Data Security

We use reasonable technical and organizational measures to protect your personal information. However, no system is completely secure.

International Data Transfers

If you access our app outside the United States, your data may be transferred and processed in the U.S., where privacy laws may differ. We take steps to ensure your data is protected consistent with applicable laws.
